Through a qualitative examination of Nerdrum's life, work, and artistic philosophy, the research highlights how his rejection of modernist trends and embrace of traditional techniques have positioned him as a pivotal figure in contemporary art. Nerdrum, often labelled a modern iconoclast, draws inspiration from the Old Masters, notably Caravaggio and Rembrandt. His declaration of being a "kitsch painter" rather than an artist marks a significant philosophical stance that has sparked both admiration and controversy. The analysis reveals that Nerdrum's works explore themes of alienation and existential inquiry while evolving to incorporate motifs of hope and redemption. This study identifies key attributes of Nerdrum's artistic philosophy, including his commitment to technical skill and narrative depth, which challenge contemporary definitions of art. By positioning himself outside mainstream discourse, Nerdrum not only carves out a unique niche but also inspires a new generation of artists seeking to reclaim traditional practices. Ultimately, this paper underscores Nerdrum's significant contributions to contemporary art and invites further exploration into the nature of artistic identity.

His ability to maintain creative independence and achieve success on his own terms raises critical questions about the nature of artistic autonomy, creative freedom, and the role of the artist in society (Cantor, 2010).

He asserts that artists should not be confined by these frameworks but instead should prioritize emotional authenticity and personal expression (Artnet, n.d.). By embracing a self-defined identity as a "kitsch painter," Nerdrum positions himself outside the mainstream art narrative, allowing him to explore themes that resonate with human experience rather than conforming to modernist or contemporary trends (Cantor, 2010).

Furthermore, Nerdrum's dedication to traditional techniques—drawing inspiration from masters such as Rembrandt and Caravaggio—enables him to create works that evoke a sense of timelessness while simultaneously challenging modernist ideologies (Deshpande, 2010). His commitment to craftsmanship and narrative-driven subjects distinguishes him from many of his contemporaries who favour abstraction or conceptualism (Steemit, 2017). As a result, Nerdrum's work often serves as a bridge between historical art practices and contemporary discourse on artistic value.

#### 2.0 Literature Review

The interrelationship between autonomy and creativity is a vital area of inquiry in artistic practices, affecting how artists express themselves and navigate their careers. Autonomy allows artists the freedom to explore their ideas and develop their unique voices, while creativity is essential in producing original works that resonate with audiences. Similarly, Munro & O'Kane (2017) discuss how the artisan economy, although promoting autonomy, often faces challenges from market pressures that can commodify creativity. They argue that the viability of artistic practices depends not just on personal autonomy but also on the socio-political context.

Moreover, Lütticken (2014) examines various conceptions of autonomy in artistic practices, proposing that while modernist notions of art's autonomy have historically been celebrated, contemporary discussions increasingly recognize the intertwining of political and artistic autonomy. These perspectives position autonomy not only as a personal experience but also as a collective endeavour that influences broader artistic movements and community identities.

#### 2.2 The Role of Structural Factors

The structure of the creative economy significantly influences the degree of autonomy experienced by artists. Hesmondhalgh & Baker (2010) highlight the complexities and ambivalences embedded in creative labour, indicating that many artists must juggle multiple jobs and face irregular working conditions that hinder true autonomy. Their findings reveal how external conditions—such as job market instability—can diminish artistic independence and creativity.

Mondon-Navazo & Murgia (2024) further complicate the narrative by discussing the resistance of artists against individualistic market demands through collective actions. They illustrate how social rights and professional autonomy can coexist, suggesting that autonomy must be understood through both individual and social lenses to appreciate the complex realities artists navigate.

Their work highlights how technology can inspire new forms of artistic expression, framing autonomy as both a personal and computational factor in creativity.

Tao (2023) emphasizes that childhood experiences significantly influence an artist's creative capacity and their perceptions of autonomy in the artistic process. #### i. Unwavering Commitment to His Vision

Nerdrum's steadfast adherence to his artistic vision is foundational to his professional approach. Despite criticism and societal pressures, he remains resolute in his ideals and beliefs about art. This focus on personal integrity ensures that his work reflects an authenticity that resonates with viewers, enabling him to create art that genuinely reflects his intentions ("The Kyoto Conference on Arts, Media and Culture 2022: Official Conference Proceedings", 2022). Such commitment consequently leads to a profound connection with audiences who appreciate the emotional depth and sincerity of his pieces, rather than seeking approval from traditional art establishments (Leder et al., 2004).

### ii. Self-Taught and Autonomous Approach

As a self-taught artist, Nerdrum avoids the constraints often imposed by formal art education and the gallery system. His autonomy allows him to cultivate a unique style that is unwaveringly his own and free from external influences (Pelowski et al., 2017). This independence fosters a creative environment in which he can explore and express his themes without the limitations imposed by conventional expectations in the art marketplace (Ortlieb & Carbon, 2019). The resulting work, therefore, is a more personal representation of his creative identity, which many find unique and refreshing in a landscape often dominated by trends.

#### iii. Disregard for Art World Conventions

Nerdrum's rejection of conventional artistic standards—such as the emphasis on originality and theoretical innovation—enables him to focus on other crucial elements like technical skill and emotional authenticity (Ortlieb et al., 2017). By prioritizing these aspects, he challenges the narrow definitions of what constitutes art, effectively expanding the artistic canon to include works that are emotionally impactful and intricately crafted rather than merely conceptual (Ortlieb & Carbon, 2019).

### iv. Embracing Kitsch and Rejecting Elitism

Nerdrum's willingness to embrace kitsch contrasts prominently with the elitism often found in higher art circles. His focus on relatable subjects—esteemed in everyday life—makes his works broadly accessible and engaging to a wider audience (Jerrentrup, 2024). By celebrating themes

This determination illustrates the profound relationship between resilience and the capacity to innovate while staying true to one's artistic intent and voice.

### vi. Authenticity - Remaining True to Himself

Nerdrum's artistic journey mirrors an unwavering authenticity that captivates audiences. Even amidst criticism, he maintains his values, leading to a profound connection with viewers who appreciate the resolve with which he stands by his artistic choices (Almaden et al., 2024). This genuine nature of his art fosters a loyal following and invites discourse surrounding the essence of contemporary art (Guthrie, 2007).

### vii. Courage – In Expressing Oddity

Lastly, Nerdrum's courage to challenge artistic norms distinguishes him as an innovative figure in modern art. He bravely explores unconventional themes and subjects that others might shy away from, demonstrating the power of artistic expression that isn't bound by societal conventions ("The Kyoto Conference on Arts, Media and Culture 2022: Official Conference Proceedings", 2022). This exploration not only enhances his work's narrative depth but also garners respect for its boldness and personal engagement with themes often deemed taboo (Souquet, 2022).

Altogether, Odd Nerdrum's art is defined by his commitment to his vision, self-taught independence, disregard for conventional standards, embrace of kitsch, perseverance, authenticity, and courage. These attributes enable him to forge a unique path, allowing his work to resonate deeply with a diverse audience.

Throughout his career, Nerdrum has faced criticism for his approach. Critics have often labeled him as an outsider within the art community due to his focus on classical techniques and narrative-driven compositions (Orlowski, 2016). Nevertheless, he maintains a loyal following among those who appreciate his dedication to craftsmanship and emotional depth. His ability to produce six to eight paintings annually demonstrates not only his technical skill but also his unwavering commitment to his artistic vision (Coussens, 2014). As he stated, "The choices I've made are in every way so hair-raising that I've reconciled myself to the fact that I will leave this life as an oddball, a victim of ridicule. I haven't seen a single sign of change in thirty years" (Webartacademy, 2010).

Moreover, Nerdrum's work is represented in several prestigious collections worldwide, including the Hirshhorn Museum and Sculpture Garden in Washington, D.C., and The Metropolitan Museum of Art in New York City (Forum Gallery, n.d.). This recognition underscores the impact of his contributions to contemporary art despite ongoing debates about his relevance in a rapidly evolving artistic landscape.

In conclusion, Odd Nerdrum's career exemplifies the complexities of maintaining creative independence amidst external pressures. His dedication to traditional techniques and emotional authenticity invites ongoing discussions about the nature of art and the role of the artist in society. By remaining steadfast in his vision and challenging contemporary norms, Nerdrum not only carves out a unique space for himself within the art world but also inspires future generations of artists to explore their own varying paths.

### 4.2 Early Life and Training

Odd Nerdrum, a prominent artist, was born on April 8, 1944, in Helsingborg, Sweden. He comes from a family of artists, which significantly influenced his early development and creative

This decision to prioritize classical techniques over contemporary trends would become a defining characteristic of his work. In addition to his studies in Oslo, Nerdrum spent time studying under the influential conceptual artist Joseph Beuys at the Kunstakademie Düsseldorf. This experience further shaped his artistic philosophy and reinforced his commitment to traditional painting techniques (Artnet, n.d.; Steemit, 2017). Beuys' emphasis on the role of the artist as a social commentator and his innovative approach to art-making left a lasting impression on Nerdrum. Throughout his career, Nerdrum's work reflects a blend of historical techniques and emotional narratives that challenge contemporary art norms.

#### 4.3 Artistic Style and Themes

Odd Nerdrum's artistic style is distinguished by his emphasis on technical skill, emotional authenticity, and timeless themes. His paintings frequently depict everyday people and scenes, rendered in a highly realistic and detailed manner. This commitment to realism is evident in his meticulous attention to detail, which allows viewers to connect with the subjects on a profound emotional level (Art Babel, 2011; Walker, 2018).

A hallmark of Nerdrum's technique is his use of chiaroscuro, a method that enhances the contrast between light and shadow to create depth and volume. This technique not only adds a dramatic quality to his work but also serves to highlight the subtleties of human emotion. Critics have praised Nerdrum for his ability to evoke feelings through his portrayals of ordinary life, transforming mundane moments into significant narratives (Deshpande, 2010; Christian et al., 2022). Chiaroscuro has been recognized as a powerful tool in artistic expression, allowing artists to convey complex emotional states and create a sense of atmosphere (Aziz, 2023).

Nerdrum often employs a "pixellation" technique, breaking up tones rather than using flat strokes. This approach involves layering paint and manipulating textures through sanding and scraping, which contributes to the overall richness of his works (Deshpande, 2010). His paintings are characterized by a unique blend of traditional methods and innovative techniques, allowing him to create compositions that feel both contemporary and timeless.

The themes present in Nerdrum's work frequently draw from historical and allegorical references, often featuring figures dressed in attire reminiscent of past eras. This choice not only situates his subjects outside of contemporary time but also invites viewers to engage with deeper philosophical questions about existence and identity (Art Babel, 2009). Through this fusion of technical mastery and thematic depth, Nerdrum has garnered widespread critical acclaim and established himself as a significant figure in the contemporary art scene.

#### **4.4 Challenges and Controversies**

Despite his considerable success, Odd Nerdrum has faced numerous challenges and controversies throughout his artistic career. One of the primary sources of contention stems from his rejection of modernist and postmodernist art theories, which has led some critics to label him as reactionary and disconnected from contemporary art trends. Nerdrum himself articulates his disdain for modernism, describing it as oppressive and claiming that it perpetuates a form of artistic racism (Worldwide Kitsch, 2018; Walker, 2021).

He argues that modernism's dominance in the art world stifles genuine talent and creativity, a sentiment he has expressed in various public statements (Worldwide Kitsch, 2018). Nerdrum's emphasis on technical skill and the use of traditional artistic techniques have also provoked criticism regarding his originality and innovation. While some view his meticulous craftsmanship as a return to the values of the Old Masters, others contend that this focus on technique detracts from the conceptual depth expected in contemporary art (Deshpande, 2010; Haskins, 2021).

Critics often question whether Nerdrum's work can be considered truly innovative when it adheres closely to historical styles and methods (Walker, 2018). In addition to these artistic disputes, Nerdrum has been embroiled in legal issues that have further complicated his public image. He has faced accusations of tax fraud, with Norwegian authorities alleging that he concealed income from taxation. Nerdrum asserts that the funds in question were not hidden income but rather set aside for restitution to collectors whose paintings had decayed prematurely (Whitehot Magazine, 2020).

This ongoing legal battle has not only drained his creative energies but also cast a shadow over his reputation as an artist (Whitehot Magazine, 2020). Moreover, Nerdrum's declaration of

himself as a "kitsch painter" during a retrospective exhibition in 1998 has sparked significant controversy. By embracing this label—a term often associated with low culture and sentimentality—he challenges traditional notions of what constitutes "art" (Walker, 2021). Critics have dismissed this self-identification as a mere ploy to maintain an outsider status within the art community (Worldwide Kitsch, 2018). Such declarations and the provocative nature of his work often place him at the centre of heated debates about the value and direction of contemporary art.
